 - e. QUANTITY OF ITEM
 - f. VALUE OF ITEM
 - g. COUNTRY OF MANUFACTURE OR ORIGIN

 - i. 9801.10.1012 is US Mfg Goods returning for repair & re-export
 - ii. 8411.21.4010 – Turbopropeller engine, less than 1100kW, for use in Civil aircraft
 - i. TYPE OF EXPORT – *(TEMPORARY)*
